To shed light . . .

The purpose of history is to shed light on the what, why, and how of the past, and often revealed through the stories of the history makers. Kudos to the Workship Committee, the choir, and Rev. Jess for the brilliant presentations of Black History Month during the February worship services. The stories of the history makers, their words and actions, and their lasting contributions all help us to better appreciate the ways in which so many communities and people enrich this society and reminds us of the United Church of Christ motto "That they may all be one" - John 17:21.

The evolving story of Pilgrimage UCC and its members continues to reveal itself month by month. The approval of our 2025 Mission Spending Plan and the Insurance Funds Allocation Plan during the Annual Financial Meeting on January 26<sup>th</sup> provides the runway for our many steps forward. For example, Treasurer Rochelle Lofstrand is collaborating with Pastor Courtney for submitting the applications for Pastor's life & disability Insurance and her retirement program.

Also, Assistant Treasurer Stephen Noffke is completing the applications for our first church credit card (a tool to better manage expenses) and for opening the brokerage account where we may invest special funds at higher rates via insured fixed investments.

By now the first service attendees have noticed that we have the AV position filled and extended to both services – progress that can be seen!

During February, the Council approved three new policies and two new procedures to shore up our employment practices and further improve our risk management. These include, "Human Resource Policy & Practices", the supporting procedures "Procedure for Onboarding New Hires and Separation" and the "Procedure for Adverse Action Process" along with the "Weapons in the Church Policy" (which is the last open task in our Safe Church Policy), and the "Substance Free Policy." Vickie Zuffoletti's assistance with all of these documents has been priceless – thank you, Vickie!

The Council also approved the Properties Committee request to hire Randy Young, retired architect, as a consultant for our real property improvement projects. Mr. Young was the architect whose firm provided the designs in 2017 for the Three R's project.

Thanks to the research by Sven Olensky, as of January 30<sup>th</sup> Pilgrimage is saving over \$400 per annum for our combined office phone line and internet service while also increasing our internet bandwidth from 300M to 1 GB

I want to thank the many volunteers who participated in the Properties Committee Nursery renovation in February – sorting, cleaning, demo work, wall prep, painting and flooring – I encourage everyone to check out this new space for our little ones (see page 3 for photos). And a special shout out to Sarah Wilson for planning, organizing and directing all these volunteers – from Monday through Saturday she spent about 40 hours in church. She also met with a contractor to review and discuss options for the NGH deck that needs substantial repair.

I also invite everyone to thank Bill and Lois Dischinger for their contribution to finding and repairing a leak in a water pipe in our front lawn; it is estimated that a gallon per minute was leaking.

On February 22<sup>nd,</sup> Vice Moderator Heyward Ottley led the Church Council Retreat at Pilgrimage through very productive working sessions such as:

- Google Chrome, Gmail and applications training by Rochelle Lofstrand.
- File naming structure for Council generated documents & files.
- Creation and use of calendars for Council & Committees, including adding timing to last year's onboarding documents.
- Heyward and Lisa Toomey leading the process to develop the RFP (Request for Proposal) for the architects; (Council members and Lynne Buell formed teams to evaluate each of the areas of the church against the input from the congregation.)

And related to our task to judiciously allocate the insurance funds via the development of a master plan, Ann Baker's motion at the January 26<sup>th</sup> Annual Financial Meeting requiring the Council to provide progress updates every three months was unanimously approved. The Council is pleased to announce that the first update will be provided within 60 days, during an informational meeting on March 30th, and the following informational session will be held at the Annual Congregational Meeting in June.



Based on the financial reports provided, here are some key trends for Pilgrimage United Church of Christ for January 2025:

- 1. The church received a substantial contributed income of \$20,467.02 but experienced a net operating loss of \$6,145.96 before other revenue sources.
- 2. The most significant expenditures were concentrated in three areas: Payroll Expenses (\$10,516.66), Property Insurance (\$4,343.25), and Properties (\$3,988.36), which together account for about 71% of total expenses.
- 3. Despite earning \$1,518.40 in interest revenue, the church ended January with a total net loss of \$4,627.56, indicating current expenses are outpacing incoming contributions.

During the financial meeting, I updated everyone on our Restricted Funds and our Insurance Money. This report combines all of our assets in one place. As a reminder, the PUCC Treasurer does not manage the Deacon Fund, but we report it as the money we have transferred out based on your donations. If you are interested in how this account is handled, please reach out to the Deacon Co-Chairs.
